

Sub.: Clarification on the issues related to the pending examination after creation of new Universities

Sir,

I am directed to invite a reference to the subject noted above and to say that the Three Vice Chancellors' Committee was constituted by the order of the Hon'ble Chancellor vide Notification Memo No. BSU/21/2018-1552 /GS(I) dated 11-06-2018 to clarify the issues related to the pending examination after creation of new Universities.

The Committee discussed the matter in detail on 11-06-2018 and resolved in the following manner:-

- (i) The Committee discussed the related issues in detail in the light of statutory provision, existing Regulations and practical consideration.
- (ii) The Committee resolves that the new Universities, viz., Patliputra University, Patna, Munger University, Munger and Purnea University, Purnea may be allowed to conduct examinations as of those students, who will be enrolled in the respective Universities from the Session 2018-19 onwards.
- (iii) It is further resolved that the students admitted in previous session in the parent Universities will continue to remain students of the parent Universities till the Degree is awarded to them. The newly constituted Universities must bear the responsibility to facilitate the parent Universities in conducting the classes and examinations.
- (iv) It is also resolved that the existing Ordinance, Regulations and Statutes of parent Universities shall remain effective until the new Universities frame their own.

Hon'ble Chancellor after due consideration of the aforesaid resolution of the Committee has been pleased to order that the above Universities will take further necessary action on the issue of examination in the light of the resolution of the Committee.
